OBJECTIVES AND INVESTMENT POLICY

- BinckBank N.V. manages the investments of this sub-fund.
- This Fund is a feeder fund (the “Feeder Fund”) and as such invests at least 85% of its assets in class I shares of LUX MULTIMANAGER SICAV – BINCKBANK – Binck Global Developed Markets Equity Fund (“the Master”).
- The Master is a sub-fund of LUX MULTIMANAGER SICAV, a Luxembourg open-ended investment company with variable capital, and aims to achieve long term returns through the exposure to equities from global developed countries.
- The Master uses the MSCI World NR EUR Index or an equivalent index as benchmark for comparative purposes (the “Benchmark”).
- The Master invests in a combination of UCITS and other undertakings for collective investment (UCIs) which either qualify as exchange traded funds or as actively managed funds which invest in shares of companies in developed markets.
- The selected UCITS or other UCIs either (i) track part or all of the Benchmark or (ii) are expected to provide risk adjusted returns compared to the Benchmark.
- The Master invests at least 70% of its net assets in UCITS.
- The Master may use financial derivative instruments and techniques and instruments relating to transferable securities and money market instruments for efficient portfolio management and hedging purposes.
- The Feeder Fund may use derivative financial instruments for hedging purposes only.
- Income is accumulated in the unit price.
- Units can usually be bought and sold each business day provided you qualify as an institutional investor.
